1. ONLY MARKET READY MEAT PENS ARE ELIGIBLE TO SELL.
2. MEAT PEN CLASSES ARE OPEN TO YOUTH EXHIBITORS FROM RIVERSIDE COUNTY. **AGES 5(AS OF 6-1-2024) TO 19 YRS. OF AGE.**
3. ALL RABBITS ENTERED IN THE MEAT PEN CLASS MUST BE EARMARKED TO CORRESPOND WITH THE ENTRY AND NOT ENTERED IN ANY OTHER CLASS.
4. PEN CONSISTS OF 3 RABBITS WEIGHING 3.5 LBS. TO 5.5 LBS. AND NOT OVER 10 WEEKS OF AGE. EACH ENTRY IS TO BE ONE BREED AND VARIETY OR CROSSBRED. PLEASE INDICATE ON THE ENTRY FORM.
5. CLASSES WILL BE JUDGED BY THE MOST CURRENT ARBA STANDARD RULES.
6. EACH EXHIBITOR MAY SELL ONE MEAT PEN. MEAT PENS WILL BE SOLD AT THE JUNIOR LIVESTOCK AUCTION.
7. NO MEAT PEN ANIMAL MAY BE ENTERED IN ANY OTHER CLASS OR IN BREED SHOW.
8. **EXHIBITORS WILL PROVIDE THEIR OWN WATER, FOOD CROCKS, AND FEED.** IF YOU WISH TO HAVE YOUR RABBITS FED ONLY BY YOU, A VISIBLE SIGN MUST BE PRESENT READING "OWNER WILL FEED". THE FAIR WILL FEED RABBITS THAT HAVE BEEN WITHOUT FOOD FOR MORE THAN EIGHT (8) HOURS.
