REQUIREMENTS



Dear Independent & Grange Exhibitors,

Read all the information carefully. Enclosed are the official forms of the Junior Independent & Grange Exhibitors record book. All records should be maintained on your project animal and submitted to the fair when requested.

Exhibitors must reside in the 46TH District Agriculture Association, composed of Riverside County.

Livestock or Small Animal Exhibitors:

Please complete the *Exhibitor Information* (pg. 4) and e-mail it to livestocksocal@gmail.com with photographs of your animal, proof of ownership, and all required information, no later than the dates below

June 7, 2025: 120-day ownership for market beef

July 7, 2025: 90-day ownership for Dairy Replacement Heifers

August 4, 2025: 60-day ownership for market hogs, market lambs, market goats, and market calves

September 3, 2025: 30-day ownership for breeding livestock, feeder stock, rabbits, poultry, and turkeys

September 13, 2025: Entry deadline

Keep all additional record book pages to assemble and turn in To the livestock office on October 3rd, 2025, by 8:00 PM.

****REMEMBER: turning in the *Exhibitor Information* form does not enter the exhibitor into the fair. Each Independent & Grange Exhibitor MUST enter online and purchase passes by the entry deadline listed above.**

NOTE: No refunds will be issued for parent/exhibitor/parking passes. More information regarding fair passes—credentials can be found in the 2025 Exhibitor Handbook.

Independent & Grange Exhibitor Timeline: Independent & Grange exhibitors entering the market and breeding animals must provide fair management with the following:

- Two pictures of their animal (a close-up side profile with exhibitor and a front view of the animal)
- Appropriate proof of ownership, Hatchery receipt, Bill of sale, Yellow slip (beef), and brand inspection (beef)
- Permanent tag, ear notch, and/or tattoo information by ownership deadline as outlined in State Rules
- *Adult Supervisor/Independent & Grange Exhibitor Leader* application forms stating who will be supervising the exhibitor at all times, due emailed to livestocksocal@gmail.com by the entry deadline listed above.

- Additional project record book pages for Livestock and Small Animal Exhibitors must be turned in to the Livestock office or emailed to livestocksocal@gmail.com no later than **Oct 3, 2025, by 8 pm.**
- Independent & Grange Exhibitors must provide insurance coverage as required by the fair for **large animals only** (purchase from the fair for \$35.00 or supply the fair with a copy of your homeowner's insurance policy). Due at the time of the entry deadline. Email to livestocksocal@gmail.com
- Must follow dress code regulations in the Exhibitor Handbook: Exhibitors shall wear a collared white short or long-sleeve shirt (rabbit exhibitors must wear a long-sleeve shirt). White or dark blue jeans. A belt must be worn. Boots may be worn, but jeans must be outside the boots.

****Failure to comply with all rules and regulations will result in the disqualification of all entries and the forfeiture of all entry fees.**
